The RIE Mysuru intend to float manual tender for allotment of Men's Saloon in the shopping complex of RIE Manasagangothri Mysuru -06 The interested firms/ Agencies may personally visit the Campus at RIE Mysuru to have the first hand information about the shop located in our Campus and submit their manual bids along with terms and conditions, if any. The contract will initially be valid for a period of 1 year which will be extendable on year to year basis up to 3 years but not more than a year of extension period, subject to satisfactory reports from committee members on obtaining subsequent approval of the Competent Authority of RIE Mysuru.

1. **The Tender shall be acceptable under two Bid Systems. The interested firms have to submit the Technical Bids and Financial bids offline / Manual Bids in the prescribed proforma at the Campus and Welfare section of the Institute on stipulated date and time.**
2. The Earnest Money Deposit / Bid Security of Rs.2000/- ( Rupees-Two thousand) only shall be payable in the form of Demand draft drawn in favour of Principal RIE Mysuru The Earnest Money Deposit / Bid Security of Rs.2000/- will be refunded to the unsuccessful tenderers/bidders after finalization of the contract. After award of contract the contractor has to deposit 10 months of rent as Security Money/ Performance Security in the form of an account payee demand draft drawn from any Nationalised Bank in an acceptable form in favour of Principal Regional Institute of Education Mysuru payable at Mysuru, Performance Security should remain valid 12 months beyond the date of completion of all contractual obligations.
3. The interested parties can inspect the premises between 10:00am to 04:30pm on any working day from 13.03.2025 to 22.03.2025 on prior appointment from the Principal, RIE Mysuru during office hours 10:00 am to 4:30 pm on any working day (Monday to Friday) for ascertaining the job requirements and any other additional information /clarification required by them.
4. All entries in the tender form should be legible and filled clearly.
5. Conditional bids shall not be considered and will be rejected summarily.

6. The Technical Bid shall be opened on the scheduled date and time.
7. The Financial Bids of only those bidders who qualify in the technical bid will be opened after evaluation by the committee constituted for the said purpose.
8. No bidding firm will be allowed to withdraw its bids after technical bids have been opened. If any firm intends to withdraw after opening of technical bids its EMD will be forfeited.
9. The Principal RIE Mysuru reserve the right to reject any or all the tenders submitted by the bidders at any time or relax/ withdraw/add any of the terms and conditions contained in the TENDER DOCUMENT without assigning any reason thereof before opening the technical bid.

**2. Opening of bids :**

- (i) The Technical bid shall be opened in the Conference Room of the Institute on stipulated date as shown at page No.1.
- (ii) Financial bids of only those bidders who qualify in the Technical Bid will be opened after evaluation by the tender opening committee.

**3. Validity of Bid**

- i) The bid shall remain valid for 90 days after the date of opening of bids. A bid valid for a shorter period shall be rejected by RIE Mysuru as non-responsive.
- ii) The Principal RIE Mysuru may, as its discretion, request the bidder for extension of period of bid validity. The request and responses thereto shall be made in writing in such eventuality of the extension of the bid validity, the valid of bid security provided shall also be suitably extended. However, modification in Bid will not be allowed at any stage.

#### 4. Earnest Money Deposit

- i) EMD amount will be accepted in the form of Demand Draft drawn in favour the Principal Regional Institute of Education, Mysuru. The Bid without EMD is liable to be summarily rejected in the following cases.
  - (a) if the Bidder withdraws his/her bid during the period of bid validity; or
  - (b) in case the successful Bidder refuses to sign the Agreement ; or
  - (c) If the bidder fails to furnish the Performance Security.
- ii) EMD will be refunded to the unsuccessful bidders within 30 days from the date of issue of award letter to the successful bidder and no interest would be paid thereon.
- iii) The Firm who are registered with National Small Industries Corporation (NSIC)/MSME/SME/ME/ Small Scale Industries (SSI) are exempted to submit the EMD (Copy of registration must be provide along with technical bid) only on submission of necessary certifications of registration.
- iv) No Claim shall lie against the RIE, Mysuru in respect of erosion in the value or interest on the amount of EMD.

#### 5. Performance Security

The successful bidder should submit the desired performance a bank guarantee in the form of DD /FDR/NEFT drawn in favour of Principal, RIE Mysuru with in the 10 working days after the acceptance of contract.

After award of contract the contractor has to deposit 10 months of the rent as Security Money/ Performance Security in the form of an account payee demand draft from any Nationalised bank in an acceptable form in favour of the Principal RIE Mysuru payable at Mysuru. Performance Security will be released only after the completion of contract period and completion of all contractual obligations.

Performance Security will be discharged after completion of contractor's performance obligation under the contract. The above Security Deposit will be liable to be forfeited during the period of contract, in case breach of any terms & conditions of the contracting contractor or failure to provide any services under the contract or loss results from contractor's failure and breach of obligation under the contract.

## **6. Acceptance / Termination of Bid**

The Principal Regional Institute of Education Mysuru reserves the right to accept or reject any bid, and to cancel the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds of the Principal RIE Mysuru.

## **7. Evaluation**

1. Principal Regional Institute of Education Mysuru shall evaluate the bids to determine whether they are complete, whether any computational errors have been made, whether documents have been properly signed and whether bids are generally in order.
2. If there is a discrepancy between words and figures the amount in words shall prevail. Prior to detailed evaluation, RIE Mysuru will determine the substantial responsiveness of each bid. A substantially responsive bid is one, which conforms to all the terms and conditions of the Bid document without material deviation. A bid determined as substantially non - responsive will be rejected by the Principal RIE Mysuru.
3. The evaluation will be based on financial offer made by the various bidders.
4. Through the evaluation will be based on the highest total amount quoted in the Financial Bid and will be considered for placement of offer. The contract will be awarded to highest rate quoted bidder.

## **8. Award of contract**

- a) The issue of a work order shall construe the intention of the RIE Mysuru to enter in to contract with the successful bidder.
- b) The successful bidder shall within 10 working days of issue of acceptance letter, on acceptance by the bidder should give his/her performance security and sign the contract with RIE Mysuru within 10 working days or date offer.

## **9. Relaxation/modification in tender: Regional Institute of Education Mysuru reserves the right to:**

-Relax the tender conditions at any stage. If considered necessary for the purpose of finalizing the contract in overall interest of RIE Mysuru.

-Re- tender or modify the terms and conditions of the tender.

-Accept or reject any or all of the financial bids in part or in full, irrespective of their being the higher, without assigning any reasons.

## संविदा की समाप्ति

### TERMINATION OF CONTRACT

- I) The RIE Mysuru reserves the right to terminate the contract at any time after giving one month's notice without assigning any reason. The decision of the Principal Regional Institute of Education in this regard shall be final and binding on the contractor.
  - II) **The contractor shall give one month's notice to the Licensor in case he/she intends to vacate the premises only during extension period of the contract.**
  - III) The contractor will on expiry of the period of the contract, peacefully and quietly hand over possession of the premises to the Licensor without raising any dispute whatsoever.
  - IV) The contractor shall not put up any permanent structure or make any alterations or additions in the premises without the prior consent in writing to the Principal, RIE Mysuru.
  - V) In case of loss or damage caused to any of the fixture etc., provided by the Principal, RIE Mysuru the cost of the damaged item shall be recovered from the contractor on spot or same shall be deducted from the Security Deposit.
  - VI) If the contractor commits breach of any of the aforesaid terms and conditions, the contract will stand terminated forthwith.
  - VII) The firm competing in the Tender must produce a relevant trade certificate from the authority.
  - VIII) In case of the contractor going in liquidation, the contract shall be treated as cancelled and legal heirs/ representatives or successors of the licensee shall not be entitled to claim any right over the licensed premises.
- 10. An opportunity to the dependant of NCERT staff is given to participate in the bid to all the shops.**

### **11. Statutory Obligations**

- a) The successful bidder/ contractor will meet all the statutory requirements obtain all necessary licenses or other approval if any required for running the shops under the relevant acts and he/she will be responsible for all the consequences for not obtaining such licences as required by the law from time to time and will have to submit the certified photocopy of the same to the RIE Mysuru and any other laws, rules , regulation, guidelines etc. that may be applicable from time to time or that may be introduced by the Central/State



Government or Municipal/Local State Government authorities subsequent to the date of this agreement.

- B) The contractor shall keep the RIE Mysuru indemnified from all acts of omissions, defaults, breaches and or any claims damages, loss or injury and expenses to which RIE Mysuru may be put to or involved as a result of Contractor's failure to fulfil any of the obligations hereunder and/or under statutes and /or any bye Laws or rules framed thereunder or any of them.

RIE Mysuru shall be entitled to recover any losses or expenses which may have to suffer or incur on account of such claims, demands loss or injury from the Security Deposit/ performance deposit of the contractor without prejudice to its any other rights under the law.

Principal RIE Mysuru will not be liable for any act or breach or omission by the contractors in regard to the statutory obligations whatsoever and shall in no case be responsible or liable in case of dispute, prosecution or awards made by Court of Law or other Government agencies.

In case of any accident arising out of and in the course of this agreement, RIE Mysuru will not be responsible for payment of any compensation or under any other law. It will be the sole responsibility of the contractor for payment towards the loss or compensation whatsoever. The person engaged by contractor shall be treated, as Contractor's own employees and can claim no privileges from RIE Mysuru. The Sole responsibility any legal or financial implication would rest with the contractor. The Contractor will be directly responsible for administration of his/her employees as regards their wages, uniforms, general discipline and courteous behaviour.

- c) The Contractor will have to obtain general insurance against risk, fire accident for his /her belongings etc. and provide a copy of the same to RIE Mysuru.
- d) All the taxes/levies/fee charges payable to Government. Department. /Local bodies shall be paid by the contractor & no claim whatsoever shall be paid by the Regional Institute of Education Mysuru.

## **12. Resolutions of Disputes**

The allotment is made as per the Public Premises Act, therefore dispute between the parties shall be decided as per the Public Premises (Eviction of Unauthorised Occupants) Act, 1971.

**13. BID Submission:**

- a. The bidder should submit the technical and financial bid on date mentioned in the page No.1 in tender notice inviting in sealed condition with separate envelopes covers super-scribing as bid for running the **Men's Saloon shop addressed to the Principal Regional Institute of Education Mysuru.**
- b. The bidder should submit Technical Bid with DDs and required documents in Technical bid, **Financial bid contains only rates, if rates found except in Financial bid the bid will be summarily rejected.**
- c. The bidder should neatly and correctly specify on the outer cover Bid for running the **Men's Saloon.**

## संविदा के नियंत्रक निबंधन और शर्तें :

### TERMS AND CONDITIONS GOVERNING THE CONTRACT:

1. In case of non-eviction of shops after permitted period, the Regional Institute of Education Mysuru may take a decision to charge double rent from the contractor with initiation of legal actions as per PP Act.
2. The 5% rent shall be enhanced on every year on subsequent extension of the contract renewal one year at once up to 3 years.
3. If a licensee does not pay rent on or before 10<sup>th</sup> day of the each month, a penalty of 5% per month on total outstanding is to be levied upon the allottee.
4. If licensee vacates the shop before permitted period of one year, the security money will be forfeited.
5. The bidder whose rates are higher will be allotted the shop. If the rates of two/three bidder are found equal/same, then the shop would be allotted on the discretion of the committee members of RIE Mysuru.
6. Minimum Rent/License Fee of the shops fixed @ Rs.1500/- per month. The bidders should quote their rate more than the minimum rent.
7. This bids should be accompanied by an Earnest Money Deposit of Rs.2000/- (Rupees: Two thousand only) in the form of demand draft, Bankers Cheque from any of the Nationalised Bank in an acceptable form in favour of the Principal, RIE Mysuru. The validity of the Bid Security shall be for a period of 90 days.
8. The successful bidder shall submit performance security within 10 working days from day of acceptance & sign the contract with RIE Mysuru along with performance security of Ten months' rent in form of an account payee demand draft, Bankers cheque from a Nationalised Bank acceptable form, in favour of the Principal, RIE Mysuru, payable at RIE Mysuru. Performance Security should remain valid for one year beyond the date of completion of all contractual obligations. Bid security should be returned to the successful bidder on receipt of performance security.
9. The licensee will not be permitted to authorize any sub-contractor or any other firm to run the shops allotted to him/her.
10. The licensee shall be in-touch with C&W section on regular basis and will also maintain his/her own register for attending any complaints/suggestions from residents/students & customers.
11. Bids shall remain valid and open for acceptance for a period of 90 days from the last date of submission of Bids.
12. Only one authorized representative will be allowed to attend the event of opening of Tenders (Technical & Financial) on presenting a letter Head of the firm which is authorised.
13. The Tender Committee reserves the right to reject any tender or all tenders without assigning any reasons thereof with the approval of the competent authority.
14. All the firms participating in the Tender must attach a list of their owners/partners etc and a Certificate to the effect that the firm is neither

- blacklisted by any Govt. Department nor any Criminal Case is registered against the firm or its owner or partners anywhere in India be attached with technical bid on non-judicial stamp paper by the Notary.
15. The tender will be rejected straightway without assigning any reason of the applicant/firm involves in any criminal cases, declared black listed by any Govt./Semi govt. department/agencies etc.
  16. In case of violation of any clause of contract/agreement deed, the explanation of the licensee can be called by issuing show cause notice, if the reply is not found satisfactory. Security money can be forfeited in full or as to be decided by the Principal RIE Mysuru as well as action for blacklisting can also be taken prior to taking any legal action.
  17. The firm will have to submit a photo copy of PAN card of the firm/individual. However, if the firm is proprietorship the proper evidence of the firm should be registered with Government agency in this regard relevant document is also to be enclosed with the technical bid.
  18. The Licensee shall, at its own cost and expenses, put up fire fighting equipment, fitting etc., such fixtures/fittings/items, which can be removed by the licensee on termination/cancellation of the contract, without damaging the building and its interior aesthetics etc.,
  19. This will be only a License Agreement and the Licensee has no right on the land of the licensed premises.
  20. The Licensed premises are public premises as defined in the Public Premises (Eviction of Unauthorized Occupants) Act, 1971 and fall within the jurisdiction of Mysuru.
  21. The Licensee shall be responsible for the maintenance, high standard of cleanliness and prevention of infectious diseases, control and prevention of nuisance from insects.
  22. The Licensee shall give special attention to the manner in which his/her employees receive visitors and render service ensuring good hospitality, congenial and pleasant atmosphere. Special care shall be taken for the employee's health and to ensure that all the workers/employees employed in the premises are medically fit and that they do not suffer from any contagious, loathsome or infectious disease. In this regard a certificate duly certified by an RMP (Register Medical Practitioner) in respect of each employee should be submitted to the C&W Section of the RIE Mysuru.
  23. The timing of the shop in shopping complex RIEM will not be 24 hours. The licensed premises shall not be used for residential purposes and the selected contractor should open the shop from 07:00am to 08:00pm on all days.
  24. The Licensee shall ensure the items sold/served from the premises are of requisite hygiene and quality standards and conform to the provisions of the prevention of Food Adulteration Act, 1954 and any other guidelines, regulation, standards, etc. issued by Authorities concerned from time to time.
  25. A rate list must be displayed at prominent places in the respective outlet, No hand bills/stickers are allowed to be put anywhere in the premises or outside.
  26. Deviation from approved trade for which licensee has been granted will be treated a violation of License Agreement and the contract shall be terminated immediately.

27. The sale/serving or promotion of alcoholic beverages and serving of Non vegetarian food is strictly prohibited.
28. **Officials of the Licensor may, at any time, enter the licensed premises/shop and monitor the quality of material, food items and standards of facilities and interiors, exteriors of the premises etc, The Licensee's duty bound to assist/co-operate with the Licensor's officials in this regard. The source of procurement for raw materials, food items etc, will also have to be divulged to the officials of Licensor whenever asked.**
29. The licensee shall not place or permit placement of any advertisement, notice frames, pictures, decorations, telephones, etc. promoting any individual's location/outlet either in RIE Mysuru or any of the place or near the allotted shop/outlets will not be allowed.
30. Segregation of waste material will also be undertaken by Licensee of outlets/shop as per local rules and regulations. Shop/outlet operators shall collect all garbage in bags/boxes/trolleys permitted for the purpose as per the guidelines of the RIE Mysuru. The collected garbage shall be kept at identified collection points, failure to do so will involve termination/cancellation of the License Agreement without any notice. It will also be the responsibility of the Licensee to maintain cleanliness and hygiene in and around their allotted shop/outlet.
31. The Licensee shall not use any sought of shamiana or space occupying things in the premises or occupy the area around the licensed premises in any manner.
32. The Licensee, his/her agents and workers shall observe/performance and comply with all applicable laws/rules and regulations of the shops and Establishment act, Factory Act, Industrial Disputes Act, minimum wages Act, Labour Laws and the provisions of any statutory law applicable to the Licensee including any rules and regulations made by Licensor or any other Department(s) of Government of Ministry of HRD or administration of RIE Mysuru as applicable from time to time to the business which the Licensee is allowed to carry on under this and to the area in which the said premises are located. This also included agreement compliance of laws relating to hygiene, storage, sanitation, cleanliness product quality and disposal of water and waste material etc.
33. Licensee can promote themselves by putting uniform signage only about their outlet name at the licensed premise only and nowhere else.
34. The preparation of premises is also to be carried out by licensee at his/her own cost after obtaining the approval from RIE Mysuru.
35. Licensee should pay Electricity and water charges every month on or before 10<sup>th</sup> day the month as per consumption without fail.
36. Firm which is going to participate in this tender is not eligible to participate if the firm has any allegation, indisciplinary attitudes over the RIE Mysuru and also the close relatives who are indulged with the above are not eligible to participate.
37. The firm which is having any litigation with the RIE Mysuru is not entitled to participate in the any bid/tender of the RIE Mysuru.
