

6. Candidates who have worked in any of the constituent units of NCERT will have to inform the tenure of their engagement and the position(s).
7. Candidates who are already in the job, should produce a "Relieving Certificate" at the time of Joining.
8. No TA/DA will be paid for attending the interview.
