- Online application closes on **23 August 2026 at 11.59 PM**.

B. Eligibility Criteria:

1. **Minimum Academic Standard:** Candidates must have secured at least **50% marks in aggregate** (or an equivalent grade/CGPA) in their Grade 12 (10+2 System) or equivalent qualifying examination.

2. **Relaxation Provisions:** A relaxation of 5% shall be granted to reserved category candidates (SC/ST/PwD).
3. **Year of Passing the Qualifying Examination:** To be eligible for the 2026-27 academic session admissions, candidates must have successfully passed their Class 12 examination within the following **three-year window**:
 - a. **Year 2024** (Pass-out candidates)
 - b. **Year 2025** (Pass-out candidates)
 - c. **Year 2026** (pass-out candidates)
4. **Status of Result:** Candidates, who have appeared for their Grade/Class 12 Board Examinations in 2026 and still awaiting their final results are provisionally eligible to apply for admission provided they have appeared in the NCET-2026 and have obtained NTA Score. Moreover, they must fulfill the minimum pass percentage of 50% (in case of General/UR Category candidates) and 45% (in case of Reserved Category candidates) and present their original Mark Sheet/Grade Sheet during the final counseling/admission validation stage.

C. Criteria for Major Subject choice

The students should have following eligibility:

S.N.	4-Year Integrated Teacher Education Programmes	Grade XII with the following subjects	NTA Score-2026 in the corresponding domain subject
1.	B.A. B.Ed. (with Major in History)	Any Subject	History
2.	B.A. B.Ed. (with Major in Economics)	Any Subject	Economics/ Business Economics
3.	B.A. B.Ed. (with Major in Geography)	Any Subject	Geography/ Geology

D. Preparation of Merit List

1. The counselling process shall be conducted and seats will be allotted in order of merit based on NCET-2026 score.

2. The NCET-2026 score comprising of seven subjects namely, Domain Subjects (1, 2 and 3), General Test, Teaching Aptitude, Language 1 and Language 2 for each subject Major shall be taken into consideration while preparing the Merit List.

Note: NCET score will be considered for 6 points after decimal or as mentioned in the score card of the candidate.

E. Application Procedure

- If a candidate wishes to apply for more than one different Subject Major, s/he must submit separate application forms.

F. Counselling and Admission

- The online counselling will be held on **25th August 2026 at 9.30 AM** using the given link: <https://meet.google.com/omp-vdnn-uyu>
- During the on-line counselling, the provisionally selected candidates shall be required to pay the requisite fee immediately in order to confirm their admissions. Fee Structure can be accessed through the given link:

- Classes for the 1st semester ITEP students have already commenced. Therefore, the candidates will be required to join the Institute immediately.
- The candidates shall be required to physically produce all original documents (the NTA-2026 Scorecard, Grade 10 Marksheet, Grade 12 Board Marksheet, Domicile Certificate and Category Certificate, EWS certificate) at the time of Physical verification of documents on the day of joining the Institute.
- All admissions shall be deemed provisional, and if any discrepancy is found at the time of admission between the uploaded documents and the physical produced original documents, the admission shall be cancelled.

G. Important Instructions:

- Applicants are requested to periodically check the RIE, Mysuru website

(www.riemysore.ac.in) for updated information with regard to the admission process. They should also regularly check their registered E-mail IDs for any message with regard to the admission process.

- Incomplete applications or applications without submission of corresponding valid documents shall be summarily rejected.
- All admissions shall be made strictly based on merit which shall be prepared taking all concerned criteria into consideration.
- All admissions shall be deemed provisional until all requirements as stipulated by the Institute are fulfilled.
- With regard to the interpretation of the provisions on any matter not covered in these guidelines, the decision of the Regional Institute of Education, Mysuru shall be final and binding on all the parties concerned.
- Any claims or disputes related to NCET-2026 and the NTA-2026 score must be settled with the NTA. The Institute will not entertain any claim or dispute in this regard.
- All legal matters concerning the admission process will be subject to the territorial/magisterial jurisdiction of Mysuru, Karnataka.
